**RESOLVED :**

THAT the Minutes of the meeting held on [21 August 2015](#) be confirmed.

8. **Declarations of Interest**

There were no declarations received at this stage.

9. [Report of the Chief Executive](#)

Prior to consideration of the report, the Sub Committee agreed to adjourn for fifteen minutes to await the arrival of the applicant.

Following this, consideration was given to the report of the Chief Executive, providing details of an application for a Premises Licence received in accordance with section 17 of the Licensing Act 2003.

Additional information, received after the printing of the report, was circulated to Members prior to consideration of the application. This included a map, a letter from the applicant in response to feedback received, and an email from the Environmental Health department.

Details of any proposed steps to promote the licensing objectives were set out in the report circulated with the agenda.

The Sub Committee followed the agreed procedure, which had previously been circulated to all parties prior to the meeting. After hearing the application, the Sub Committee presented the following decision and the reasons for that decision.

**RESOLVED:**

THAT upon receiving the report of the Licensing Section, oral and written evidence from the applicant, responsible authority and other persons and having regard to the Guidance issued under s182 of the Licensing Act 2003 and the Isle of Wight Council's Statement of Licensing Policy 2014 - 2019, the application be determined as detailed below:

**Application:**

A Premises Licence for Cardamon Lounge, 44 High Street, Carisbrooke, Isle of Wight.

**Resolution:**

THAT the application for a Premises Licence for Cardamon Lounge, 44 High Street, Carisbrooke, Isle of Wight be granted in accordance with the application, the subsequent amendments as agreed with the police including the conditions (as detailed within pages B – 33 and B – 34 of the report attached to and forming part of these minutes), and subject to those conditions proposed by the applicant within the operating schedule and the mandatory conditions specified in the Licensing Act 2003.

**Conditions:**

As published within the committee report, including those conditions proposed by the applicant within the operating schedule and as amended in consultation with the police at page B – 34 of the report.

**Reasons for Decision:**

Members considered that all remaining relevant licensing objections had been adequately addressed by the modifications, and that Environmental Health issues would be satisfactorily dealt with by alternative legislation.

In reaching the decision the Sub Committee had regard to the Human Rights Act 1998, and in particular Article 1 of the First Protocol, Article 8 and Article 6. The Sub Committee considered their decision to be proportionate and appropriate for the promotion of the four licensing objectives under the Licensing Act 2003.

All parties were advised that they had a right of appeal to the Magistrates Court if they were dissatisfied with the decision, and that any such appeal had to be made within 21 days from the date of notification.
