## Objections received during the consultation period

**COMMENTS:** This Application was not seen by Adgestone residents until recently, due to (i) there being no apparent Press Notice (unlike Planning) and (ii) no-one walking by, due to local flooding. Living in a single-track road in an AONB, we already have the 'dusk drivers' leaving the Golf Course, and seemingly in a great hurry to get home. What should be a pleasant evening walk is often beset by inconsiderate drivers.

This latest application for 'Live and Recorded Music', Mon-Sun, 2300-0100, with associated Supply of Alcohol will have two effects on local residents:-

- (1) the clubhouse is an short distance across the marshes from local properties. Potential seven days a week noise until 1am will be a severe annoyance.
- (2) there is no public transport near the club and many attendees are expected to use the local lanes on leaving. This will create traffic noise and a potential hazard for anyone else not using motorised transport.

Though I would not object to all late night events at this venue, I would like to see a small limit placed on the number of occasions such that this did not become a new 'night club'.

- 1) increased noise much later at night in the hamlet of Adgestone which is both an unlit rural area of narrow roads and a designated quiet area. The increased traffic flow with departure times from functions will now be much later than currently experienced 01:00 instead of 23:00.
- 2) the possibility of noise disturbance from the music source at the Golf Club during warm / hot evenings, particularly in the summer, unless they adhere rigidly to the stated condition of having their windows closed whilst music is in process. We would ask if the club is airconditioned?
- 3) the consumption of alcohol is being requested for both inside and out. Does this imply that the balcony shown on the supplied plan or another outside area will be used by their guests whilst music is being provided and if so how will the Club guarantee the condition referred to in point (2) above?
