RESOLVED:

THAT the Minutes of the meeting held on Monday, <u>8 February 2016</u> be confirmed.

17. Declarations of Interest

There were no declarations received at this stage.

18. Report of the Head of Planning and Housing Services

An Application for a Premises Licence under Section 17 of the Licensing Act 2003 for Tradewinds Café, Dunroamin Beach, Lake, Isle of Wight

Consideration was given to the report of the Head of Planning and Housing Services, providing details of an application for a Premises Licence received in accordance with Section 17 of the Licensing Act 2003.

Members were advised that due to three representations received in objection to the grant of the licence which had not been resolved informally, the application was required to be determined by the Sub Committee. Fifteen representations had also been received from other persons in support of granting the application.

Additional information, received from an objector and a supporter after the printing of the report, was circulated to Members prior to consideration of the application. Details of proposed steps to promote the licensing objectives were set out in the report circulated with the agenda.

The Sub Committee followed the agreed procedure, which had previously been circulated to all parties prior to the meeting. After hearing the application, the Sub Committee presented the following decision and the reasons for that decision.

RESOLVED:

THAT upon receiving the report of the Licensing Section, oral and written evidence from the applicant and other persons and having regard to the Guidance issued under s182 of the Licensing Act 2003 and the Isle of Wight Council's Statement of Licensing Policy 2014 - 2019, the application be determined as detailed below:

Application:

A Premises Licence for Tradewinds Café, Dunroamin Beach, Lake, Isle of Wight.

Resolution:

THAT the application for a Premises Licence for Tradewinds Café, Dunroamin Beach, Lake, Isle of Wight be granted in accordance with the application, subject to those conditions proposed by the applicant within the operating schedule, the mandatory conditions specified in the Licensing Act 2003, and also those agreed with the police as published at page B – 28 of the report (attached to and forming part of these minutes).

Conditions:

As per the conditions agreed with the police at page B-28 of the committee report dated 29 February 2016.

Reasons for Decision:

Members noted the objectors' concerns but were satisfied that the licensing objectives were to be adequately promoted.

In reaching the decision the Sub Committee had regard to the Human Rights Act 1998, and in particular Article 1 of the First Protocol, Article 8 and Article 6. The Sub Committee considered their decision to be proportionate and appropriate for the promotion of the four licensing objectives under the Licensing Act 2003.

All parties were advised that they had a right of appeal to the Magistrates Court if they were dissatisfied with the decision, and that any such appeal had to be made within 21 days from the date of notification.
