Closing a window will do no more than exacerbate a conflict, boiling over on the street outside. CCTV coverage already on Newport streets, does little to ameliorate aggressive behaviour. Business is in a mixed usage area. All adjacent properties (86 - 92) have occupied residential accommodation above the businesses. 2 years ago planners granted application to develop 3 - 4 residential units next door to this business, with rear aspect backing onto rear entrance/kitchen. The granting of this application could create a potential melting pot of violence and unrest as revellers leave SIA monitored premises to make their way home. This does nothing to expedite their journey SAFELY home.
