Application:

A Highway Amenity Permission Under Section 115A of The Highways Act 1980 for the Coast Bar and Dining Room, 14-15 Shooters Hill, Cowes, Isle Of Wight, PO31 7BG

Resolution:

THAT the application be granted, subject to the Highway Authority's standard conditions but also subject to a condition which states:

Conditions:

The Licence does not permit the erection of tables chairs and planters or any other obstruction of the highway between the hours of 08:15 – 10:00 each day, during which times such tables chairs planters and any other obstruction shall only be permitted on the highway for the purposes of storage if stored in strict accordance with a scheme for storage issued under this licence and agreed in writing with the Highways Authority.

Reasons for Decision:

The reasons are in order to mitigate the increased risk to public safety by causing an otherwise unacceptable obstruction to the highway.

In reaching the above decision the sub-committee have also had regard to the Human Rights Act 1998, and in particular Article 1 of the First Protocol, Article 8 and Article 6 and consider this decision is proportionate and necessary for the promotion of the legitimate policy aims of the council.
