Good Morning Andrea,

Thank you for your email yesterday.

We have taken on board Cowes Town Council's comments and appreciate the concern raised. I have revised my risk assessment (please find attached) and would like to state the following:

For at least the last four years we have had street furniture outside our premises from 8am/8.15am this has never been a issue previously and cant understand why it has been raised now, yes I appreciate that these barriers are different from previous submissions however the outcome would be no different. The previous barriers were side poles top and bottom with heavy hard standing upright poles which in all honesty I believe posed more of a hazard than these current barriers. The previous barriers could have given the impression a person could squeeze past moving traffic where theses are very clearly more durable. I have monitored the high street this morning and have clearly seen pedestrians use the public high way before 10am which we all do, this is nothing new. Our barriers are no different when Sainsburys have their deliveries and their cages are blocking the whole side of the pedestrianised zone and there is passing traffic using the public highway.

With regards to the questions above:

a) We can not amend the application to 10am (please see stated reasons why below)

b) yes we do have provision to move the items from the highway outside of the permitted times.

The reason I can not amend the application to 10 am is due to health and safety reasons. The barriers are stored in our restaurant when not outside. The movement of these barriers needs to be completed before we are open to the public for the safety of our staff and customers. Also with monitoring the high street between 8am and 10am, 8am to 8.30am is the quietest period in which to manoeuvre the barriers and furniture without posing a higher risk to our staff and the public.
