#### Details:

Proposed glamping pods, reception and ablution block, amenity ponds and associated parking (revised scheme)(revised plans)

Land South of Newclose Cricket Grounds, Blackwater Road, Newport.

### **Additional Representations:**

Paragraph 5.14 included comments in support of the application theses had been made on a previously withdrawn application and did not relate to the application presented to the Planning Committee.

A further comment had been received from residents who had made previous comments.

### Comment:

Councillor Clare Mosdell spoke as Local Member to this item.

The Committee asked for clarification regarding parking on the site, there didn't appear to be staff parking allocated, they also asked if it would be possible to prevent cars being driven on the site, it was assumed that people would drive to the glamping pods and then return their cars to the allocated spaces. It was confirmed that the scheme included a new footpath, a bridge to link to the existing Sandown-Newport cycle track and two new bus stops outside of the site, within Blackwater Road.

Concerns were raised that people would not want to walk along the cycle track at night, from the town, they may therefore walk in the main road, which would be very dangerous.

Questions were raised as to whether the faculties block was of sufficient size for the scale of the development and where the foul water would go.

Members questioned the safety of the proposed ponds and what lighting would be available on site and if it would comply with the dark skies policy, they were advised that a condition was proposed to ensure appropriate fencing was erected around the pond areas and that any lighting would not impact on ecology and would therefore be low impact., It was also confirmed that there was not a dark skies policy currently in place and the application did not fall within an Area of Outstanding Natural Beauty.

Members discussed the possible pollution impact the proposal would have on the environment and CO2 emissions, as people would be using Barbeques and wood burning stoves which had been discouraged by government.

Concern was raised regarding the noise that could be generated by people using the site and the impact on the quality of life of neighbouring residents, and believed the proposal failed to enhance the local area.

#### **Decision:**

A proposal to approve the application in accordance with the officer's report was made and seconded, a vote was then taken, and the proposal fell, a further proposal to refuse the application was made and seconded, in accordance with the Council's Constitution a named vote was taken.

Questions were raised regarding the proposed highway works included as part of the application when it was originally submitted and why this had been removed from the scheme, they were advised that Island Roads had reviewed the original submission and found significant highway safety concerns regarding the pedestrian area and turning of large delivery vehicles. Revised plans were therefore submitted removing this element of this scheme.

Members were also informed that if the committee approved the proposal, future highway works could still be implemented in the area following a separate application process.
