EXECUTIVE SUMMARY

1. The purpose of this report is for the committee to receive the external auditor's annual audit letter which effectively concludes the auditor's work in respect of the financial year 2013-14.

BACKGROUND

2. The external auditor's 'Annual Audit Letter' in respect of the financial year 2013-14 is shown at Appendix A. It represents the formal conclusion to the auditor's work and findings that have already been reported to the committee when it met in September. As such, there are no new findings in the letter.

STRATEGIC CONTEXT

3. The work of the council's external auditors provides an entirely independent opinion on the council's financial reporting and cost –effectiveness of council services. It therefore makes an effective contribution to the council's governance arrangements.

4. The Annual Audit Letter has been discussed with the Managing Director and the Head of Financial Management & Section 151 Officer.

6. The external auditor is required to report to members in accordance with Part II of the Audit Commission Act 1998 and in accordance with the Statement of Responsibilities of Auditors and of Audited Bodies published by the Audit

Commission in 2010. The auditor is also required under the Audit Commission Act 1998 to be satisfied that proper arrangements have been made by the council for securing economy, efficiency and effectiveness in its use of resources.
