| 10 March | 9 confirmed cases. 1 on the Isle of Wight, 8 in Hampshire, 0 in Southampton and Portsmouth |
| 11 March | NHS are at level 4 incident (the highest level). Budget released by Exchequer: £5bn for NHS and public services, those self-isolating are paid statutory sick pay, self-employed can claim contributary employment support allowance. £500m for councils to help the most vulnerable. Firms with less than 250 staff will be refunded for sick payments for 2 weeks. |
| 12 March | Schools are to remain open. Move from contain phase into delay. UK Chief Medical Officer raised UK risk level from Moderate to High |
| 13 March | People with a continuous new cough and high temperature must isolate for 7 days. People aged over 70 and those with serious medical conditions advised against going on cruises |

A three-week peak in the pandemic is expected at end of May/start of June. Death rate 22,995-60,150 people. There are 3750 acute beds in HIOW NHS. | 20 April | It was announced that lockdown has been extending until at least 1 st May. The Portsmouth Tipner testing site is open for key workers to drop in on 21 st and 22 nd . |
| 24 April | The military send a mobile testing unit over to the IOW for the next 4 days to conduct 450 tests a day. A national online booking system was launched, however due to demand it was closed to further bookings. |
| 24 April | The Secretary of state announced a package of financial support for Ferry links to the IOW. |
| 27 April | 1-minute silence at 11am for healthcare workers who have died of coronavirus. The number of care home with outbreaks has been highlighted. |
