Title	DELIVERY REPORTS FROM STRATEGIC PARTNERSHIPS

EXECUTIVE SUMMARY

1. The delivery of the Isle of Wight Health and Wellbeing Board Strategy 2012-16 is being implemented through a number of key partnership bodies, which are accountable for the delivery of the strategy and other important local outcomes for the island. The board has asked for periodic updates on the progress of each partnership body, their priorities and the challenges that they face.
2. This report is the second of a cycle of delivery reports that summarise progress on a quarterly basis. The report provides an opportunity for the board to consider and reflect on the delivery activity of the Children's Trust. The board also has the opportunity to reflect on summary activity reports from other key partnership bodies.
3. Delivery reports are intended to inform the board and strengthen its awareness of actions being taken to deliver *the Isle of Wight Health and Wellbeing Strategy 2012-16*.

BACKGROUND

4. The board has received regular summary reports on progress and key issues from the partnerships charged with delivering the Isle of Wight Health and Wellbeing Strategy 2012-16. Since May 2014, reports provided to the board have been set out in the format agreed by the board and set out in the board's guidance document; *Effective Delivery of the Health and Wellbeing Strategy 2013-16*.
5. It is the role of the board to ensure that the outcomes set out in the board's strategy, and the content of the *Isle of Wight Joint Strategic Needs Analysis (JSNA)*, are reviewed and changes made where needed. It was agreed by the board in June 2013 that regular reporting of delivery activity and issues will contribute to this role. Delivery reports and summaries are intended to provide the board with an opportunity to identify the key priorities and issues facing delivery partnerships, and to promote discussion and action that will contribute to future review of both the strategy and the JSNA.

A PROGRAMME OF REPORTING

6. While reporting of activity is essential information for board members, the delivery partnerships are also engaged in a wide range of reporting activity for strategic and operational reasons. Collecting this information and organising it in the various formats required, places a necessary but significant burden of cost and time on lead partners. For this reason, while delivery reports to the board are intended to provide a focus for discussion and action, it is essential that the reports requested of each delivery partnership draws upon the body of reporting information already invested in by partner organisations.
7. At the Health and Wellbeing Board in May 2014, board members focused on the reports of the My Life: A Full Life programme and the Isle of Wight Community Safety Partnership. The focus for reflection by the board in the second quarter of the reporting cycle, is a report summarising the activities of the Children's Trust, attached as Appendix 1. The Children's Trust is accountable for the delivery of the Isle of Wight's health and wellbeing objective of ensuring that *"Children and young people have the best possible start in life"*, at the September 2014 meeting of the board.
8. Appendix A summarises a number of key measures of progress and rates overall progress toward delivery of the Trusts high level objectives as 'green', which indicates that the plans of the partnership are on target.
9. A number of achievements are set out that contribute to the delivery of the strategic objectives agreed for children and young people on the Island. These achievements include the awarding of funding to organisations that will now deliver youth services, and significant improvements in school attendance.
10. A number of challenges are also noted. These include the need to address the impact of the government's deficit reduction plans and the impact of welfare reform on local children and young people. Other significant challenges include the Island's notably high under-18 conception rates, which represent a continuing challenge to partners accountable for responding to and reducing the impact of early pregnancy.
11. Summary reports from other partnership bodies are attached as Appendix 2. This includes reports from the following:
 - The My Life A Full Life partnership reports on the objective that *"People are helped and supported to prepare for old age and to manage long-term physical and mental health conditions and disabilities"*.
 - The Isle of Wight Community Safety Partnership reports on the objective *"The Isle of Wight is a better place to live and visit"*.
 - The Healthy Communities partnership reports on the objective that *"People make healthy choices for healthy lifestyles"*.
 - The Isle of Wight Council, reports on the delivery of the objective *"Sustainable economic growth for the Island supports improved employment opportunities"*.

PARTNERSHIP ISSUES

12. It is acknowledged by delivery partnerships that it is important for the board to have reports on the implementation of the strategy and the wider partnership issues. It is intended that through these reports, partner organisations will have an opportunity to reflect on and discuss progress toward the objectives of the board's strategy. This will support the principal role of the board as a forum for considering and assisting action that will ensure the current and future delivery of the health and wellbeing strategy.
13. However, partnership board leads have asked that the board recognise the potential burden of extensive and detailed reporting over and above that agreed by the board in June 2013 and presented with this report. The form and value of future reporting to the board will be an issue that the various partnership bodies will wish to re-assess in discussion with the board at a future review of the boards strategy.
14. Partnership lead officers will assist board members who wish to know more about the work of each delivery partnership, its priorities and impact.

RECOMMENDATION

15. That the board notes the reports of the partnerships and bodies charged with delivering the Health and Wellbeing Strategy 2013-2016.
