## 1. Reflection

## 3. **Declarations of Interest**

None were received

## 4. Minutes

#### **RESOLVED:**

THAT the minutes of the meeting held on 27 June 2022 be approved.

THAT the action point resulting from the minutes, regarding whether the resources available on the MOODLE were free to all, was confirmed as being accurate.

THAT the action point about the syllabus being available in larger text was discussed and options for this considered.

## 5. **Membership Update**

Members were informed that Ben Britten, Mike Hackleton, Alex Augusta and Liane Chalmers had stood down from the SACRE. The Chairman thanked them for all their contributions and respective work for the SACRE.

New members were introduced to the committee - Rebecca Lennon was welcomed to join Committee C as Headteacher Member, Janice Willcott and Sue Rogers were welcomed to join Committee B as Church of England Members. These were to go to full Council for approval.

The Chairman also commented on how wonderful it was to see the meeting so well attended.

## 6. Election of Vice Chairman from Committee A

The Chairman explained the process of electing a Vice Chairman, according to the SACRE constitution, and highlighted the fact that the Vice Chairman normally assumed the position of Chairman after 2 years. It was asked if any members from Committee A were interested in standing as Vice Chairman and if so, could they inform the Professional Adviser.

## 7. Draft Annual Report

Members were asked to go into their respective committee groups to discuss the draft annual report for approval and comment.

## **RESOLVED:**

THAT the draft annual report be approved with any comments arising from the individual committees be given consideration for inclusion.

## 8. Self-Assessment with NASACRE Self-Assessment Tool

Members were asked to go into their respective committee groups to use the NASACRE Self-Assessment Tool as a method of evaluating and assessing how the Isle of Wight SACRE was performing. It was asked that the Committee members email the Clerk and the Professional Adviser with any comments regarding their findings through the self-evaluation tool.

#### RESOLVED:

THAT any comments resulting from the individual committee discussions be emailed to the clerk and the Professional Adviser for consideration.

## 9. **Monitoring Report**

It was explained to members that there was a small group, who meet as a monitoring group, to look at the monitoring duties of the SACRE in further detail. If any other members were interested in joining the monitoring group, they were asked to get in touch with the Professional Adviser.

The monitoring group discussed the need to have a focus on collective worship, as well as RE instruction, on school visits, and this would be put into place for the visits taking place in the Spring term.

The Professional Adviser to the SACRE stated that 2 school visits were planned before the March 2023 meeting of SACRE. Ideally, it was hoped that one of the school visits would be to a special needs school.

The subject of Ofsted reports on the teaching of RE in schools was discussed and it was commented upon that there was little focus on RE in Ofsted reports, but what had been able to be viewed was very positive.

It was mentioned that the RE Network for primary had started again with the secondary network coming onboard after half term.

Discussion then took place about communication with schools and how the SACRE could support schools.

## **RESOLVED:**

THAT there was to be a greater focus on collective worship as well as the teaching of RE during the monitoring visits.

THAT attention be given to how SACRE could best communicate with schools.

THAT attention be given to making sure information sent to the schools from SACRE was getting to the key people in the school involved with the teaching of RE.

#### 10. Review of the Constitution

It was stated that the SACRE constitution was last reviewed 5 years previously and it was time to review it again.

It was explained that a meeting with the IW Council Monitoring Officer, the IW Council Scrutiny Officers and the Professional Advisor to the SACRE was planned for November 2022, with the purpose of reviewing the SACRE constitution.

The smaller group, which had been established at the last meeting of the SACRE in June to review the Constitution, would meet after the November meeting to discuss points raised and formulate an updated draft constitution. This would then come back to the committee to vote on, in the SACRE March 2023 meeting.

## **RESOLVED:**

THAT the Professional Advisor and Chairman report back to the SACRE constitution review group after the meeting with the Monitoring Officer, and that they would discuss and formulate any proposed changes. These would then be included in a draft update of the Constitution, which would be presented to all members at the March meeting.

## 11. Living Difference IV update

It was highlighted that it was a year on from when Living Difference IV was first introduced. It was now well established and known by schools, many of whom were now going ahead in adopting Living Difference IV.

The benefits of the 'Golden Threads', which weave through the whole RE curriculum from primary to secondary, were now being seen and were becoming invaluable, particularly in the transition from primary to secondary.

The ideas of faith groups were discussed with the emphasis that faith groups were not homogeneous in the interpretation of a particular faith and that many individuals within a particular faith group, interpreted and practised their faith in different ways.

It was mentioned that religious hate crime had increase by 37% in the past year.

The up-and-coming Interfaith week 13 Nov-17 Nov at Brighstone Primary was discussed, and members were encouraged to get in touch with Brighstone Primary should they wish to attend.

#### **RESOLVED:**

THAT the progress of Living Difference be noted.

THAT the Interfaith week be publicized amongst SACRE members.

## 12. Future timings of SACRE meetings

The future timing of SACRE meetings was discussed, but it was decided that 4pm was the most convenient time.

#### RESOLVED:

THAT the meeting time remained the same, but that this can be reviewed.

## 13. The possibility of SACRE meetings to be held remotely

It was highlighted to members that, should meetings be held virtually or in a hybrid format, members attending on-line could not vote on any issues.

The idea of holding one meeting a year virtually was floated though this needed to be checked with the Monitoring Officer in the November meeting.

## **RESOLVED:**

THAT the Professional Advisor report back on this issue after her meeting with the Monitoring Officer in November 2022.

## **EXECUTIVE SUMMARY**

## 1. Purpose of report:

The purpose of this report is to inform SACRE of the findings and discussions that took place during the meeting of the SACRE monitoring sub-group on 20 February 2023. SACRE has a statutory responsibility to monitor the effectiveness of the agreed syllabus and this group meets before each full SACRE meeting in order to support SACRE in fulfilling this responsibility.

Those present at the meeting were: Justine Ball (Sacre Professional Adviser), Harry Kirby Beth Feltham and Cllr Debbie Andre.

The group received updates on professional RE education, monitoring the effectiveness of RE and an update of results from the GCSE examination series in 2022. Further updates on the 2021 census results on religion and the monitoring survey for RE and Collective Worship were discussed.

## **Recommendations:**

That SACRE notes the findings of the monitoring group meeting.

## 2. Inspector/Adviser Updates:

HIAS Primary and Secondary RE Network meetings have taken place virtually for Island teachers in the Spring term. Teachers have been discussing overview studies and pondering time as well as ways to assess RE and provide evidence of RE teaching in the meetings. Island teacher have also attended RE courses on the mainland, such as Assessing RE and Collective Worship. An Island Collective Worship training event was held for teachers at the Bay Secondary School on Thursday 8 March to share best practice and examples of Collective Worship across the island. The monitoring group requested that the SACRE consider RE training for governors next year and ways to promote youth voice to SACRE – for

example by a conference/event for upper primary and lower secondary children on RE.

## 3. Updates on the Isle of Wight 2022 GCSE Religious Studies examinations

It was noted that only 3 schools had entries for the GCSE RS and that 23% of the cohort of students were entered for Religious Studies, which is a drop in numbers compared to previous years. The results were below national and significantly below national at 1, 5 and 7+ indicators.

The group discussed what they could do to help with this and went on to discuss recruiting Religious Studies teachers on the Island. It was commented that it had been very difficult to recruit RS teachers on the island and that word of mouth had been key to recruitment rather than adverts. It was stated that Religious Studies was worse than other subjects for recruitment. This may be a factor when considering GCSE results here. The group discussed ways to increase the awareness of the value of the subject for schools, for example through training for Senior Leaders and for Governors on the value of RE. It was agreed that the group would run training for governors in the next academic year as a way of increasing the profile of Religious Education in schools and promoting conversations about the subject more widely in schools.

The group also discussed raising the profile of the subject to help with GCSE take up by working on the Youth Voice to SACRE in the next year and considering a conference with primary and secondary young people, so that young people themselves talk to others about the subject and its importance on the school timetable.

Justine Ball noted dropping numbers of RE specialist teachers was a national concern. The Association of University Lecturers in RE (AULRE) and the National RE Council were raising awareness of the benefits of teaching RE and information about this campaign can be found here: New RE teacher recruitment campaign kicks off as popular GCSE subject faces staff shortage (natre.org.uk)

#### Other sources of evidence of effectiveness of RE:

The Inspector/adviser reported that there were very few mentions for RE specifically in the Ofsted reports for Isle of Wight schools. There were two schools that had comments specifically relating to RE and both were positive, with comments made about the value of learning about different religions and traditions and the importance for this in helping children prepare for life in modern Britain.

## 4. Monitoring RE and Collective Worship (CW) Survey:

A survey had been sent to Headteachers of Island schools early in the Spring term. 19 Island schools responded and the numbers withdrawn from RE and Collective Worship in the responding schools were very low:

All of RE: 2 children Parts of RE: 8 children

All of Collective Worship: 8 children Page 12

Parts of CW: 8 children

The reasons given were the beliefs of the parents, whether religious or non religious.

#### 5. School visits:

Two school visits had been undertaken with RE leaders who attend the Island RE networks. These had a focus on the RE curriculum to explore how the subject is engaging, meaningful and interesting for all children. Work was discussed mapping golden threads in schools to ensure more rigour, show progression and be engaging. Floor books and ways of recording information as a subject leader were also discussed.

## 6. UK Census 2021

The Professional Adviser introduced a report on religious activity in our area drawn from the 2021 UK Census, which had been prepared and circulated. She stated that she shared this information with schools at the recent RE network. The results are as follows for the Island:

43.9% had no religion

47.7% Christian

0.4% Buddhist

0.2% Hindu

0.1% Jewish

0.4% Muslim

0.0% Sikh

0.8% Any other religion

The results nationally were as follows for comparison:

- Less than half of the population (46.2%, 27.5 million people) described themselves as "Christian", a 13.1 percentage point decrease from 59.3% (33.3 million) in 2011; despite this decrease, "Christian" remained the most common response to the religion question.
- "No religion" was the second most common response, increasing by 12.0 percentage points to 37.2% (22.2 million) from 25.2% (14.1 million) in 2011.
- There were increases in the number of people who described themselves as "Muslim" (3.9 million, 6.5% in 2021, up from 2.7 million, 4.9% in 2011) and "Hindu" (1.0 million, 1.7% in 2021, up from 818,000, 1.5% in 2011).

## **EXECUTIVE SUMMARY**

**2.** Executive Summary:

This report seeks to update and inform SACRE of key national development, for example the work of the Religious Education Council (REC) and NASACRE as well as the Association of University Lecturers in Religious Education (AULRE) and initiatives being led by the Culham St Gabriel's Trust.


**3.** Culham St Gabriel's Trust initiatives: Portsmouth SACRE members will be interested in several initiatives that are being funded by the Culham st Gabriel's trust; the largest grant giving body supporting religious education <a href="Homepage-Culham St Gabriel's (cstg.org.uk">Homepage - Culham St Gabriel's (cstg.org.uk)</a>.

#### These include:

- (i) The National RE Leadership programme: for RE teachers who are beginning on their journey of RE advising. The deadline for this is the end of March 2023 and the link for stage 1 and for stage 2 of the programme is here:

- **4.** The National RE Hubs Project is a new national project that aims to create a national RE website to link Local Authorities, Universities, SACREs, Museums, ITT providers, RE groups and RE advisors across England and Wales. The website will have 9 English regions and 1 for Wales. Each area will have events, regional RE news, RE blogs, job vacancies, resource centres, places of interest and school speakers and space for local groups. The project has offered free places of interest and school speaker training with dates throughout the year and further information can be found here RegionalREHubs training (natre.org.uk). The Primary RE adviser is the South East lead for this project.
- **5.** The Association of University Lecturers in Religious Education (AULRE) is still leading on the matter of issues in relation to Secondary Initial Teacher Education (ITE). Recruitment for 2022/23 is considerably reduced and efforts are ongoing to ensure increased recruitment for 2023/24 intake. AULRE is raising awareness of this issue nationally and working with a range of groups to increase numbers on RE and ITE courses.
- 6. National Association of SACREs (NASACRE). NASACRE is the national body representing and leading on SACREs interests. A regular newsletter is circulated to SACRE members through their SACRE. In addition, a series of training sessions are offered for SACRE members to attend. The NASACRE Annual Conference and AGM will be held on 22 May 2023 in London. SACRE members are invited to consider whether they would like to attend.



## **Code of conduct**

This generic code of conduct has been drawn together from consideration of various existing codes and provides an example for SACREs to use or adapt.

## **General principles**

xxxxx SACRE encourages all its members to:

- attend all SACRE meetings and take a full and active part in its work
- participate in and review the work of SACRE for the benefit of the whole community
- listen with respect to the views of other members and where a situation of disagreement occurs, disagree respectfully
- express views and opinions openly, honestly and sensitively, always recognising others may have views different to one's own
- assume at all times that other members of SACRE are honourable and concerned with the best interests of SACRE
- seek reasoned consensus where views diverge and never disrespect the views of other SACRE members or seek to convert them to a different belief stance
- actively consult with, and report back to, the membership body which they represent so that debate is fully informed
- actively challenge and resist stereotyping

Remember that the central aim for the SACRE is to improve the quality of provision in RE and collective worship for all pupils in xxxxx.

## **Visiting schools**

From time to time, SACRE members may have the opportunity to visit schools.

SACRE Members should remember that it is a privilege to visit a school. They are there as invited guests, not to make judgements about the school or to "inspect" RE and collective worship.

## Members should:

- only visit a school when invited
- inform the Clerk of SACRE and the SACRE's RE Professional of any invitation received and visits made
- ensure that you do not say or do anything, which could be viewed as denigrating any religion or ethical belief system

- avoid being critical of others or imposing their own views
- any confidential information disclosed should not be passed on but along with any
  possible concerns or confusions about what may have been seen should be discussed
  with the LA Officer and RE Professional before being reported back to SACRE

## Visiting schools as a representative of a faith community

Some faith community representatives may be more regular visitors to schools and invited to support RE and/or collective worship.

Visitors should be well-supported by the class teacher who should always be present, taking an active role in question and answer sessions, and ensuring visitors are well-briefed before a visit.

SACRE members visiting a school to share their beliefs, values and experiences should:

- have a clear, mutually agreed understanding of the purpose of the visit before it takes place
- appreciate that they are not there to convert or proselytise, avoiding being critical of others or imposing their own views
- be familiar with the school's aims, ethos and policies in RE and collective worship;
- have an understanding of where the lesson will fit into the unit of work from the Agreed Syllabus and what the learning objectives are
- use a variety of teaching and learning methods and approaches, but at no time touch pupils or behave favourably towards pupils of particular faiths, ethnic groups or genders
- ensure that pupils understand that the visitor is representing a particular faith view and their own personal interpretation of it and therefore that others from the same faith may not always interpret ideas in exactly the same ways
- ensure that they do not say or do anything, which could be viewed as denigrating
- communicate at an appropriate level for the age group concerned
