

#### 16. Monitoring Report

The Adviser to the SACRE welcomed RE Leaders to the meeting.

A brief explanation of the purpose of the Monitoring Group was provided, looking at RE and collective worship across all schools looking at:

- Resources
- Visits
- Ofsted reports

The Monitoring group had met twice since the last SACRE meeting in June 2023. Primary schools had worked well on the golden threads and resources were available on the Moodle. Discussions around overview studies and how to apply light touch teaching in schools took place. Optional pondering time was included in the syllabus for one unit a year. However, it was noted that take up in primary was light and there will be a focus on this to get further advice out to primary school teachers.

Training session for Governors and SACRE had taken place in July 2023 on RE and Collective Worship, another session was in the diary for March 2024.

The RE lead at the Bay secondary school provided a summary of her approach to GCSE at the school. She explained that all lesson information was made available online for students to access online both at home and during school and there was an expectation that if a student missed a class then they would catch up before the

next lesson. Revision guides are provided for each student. Students joining the school late in the year are provided with packs of work that had already been covered by the class to help them catch up with the work and one to ones are set up to ensure the student is caught up in time for their exams.

It was noted that students moving from primary to secondary school had good knowledge of RE and presenting orally, however the skill of evaluating and written skills were a focus when starting in secondary school.

#### 17. National and Local Matters

There are a number of bodies that are good for CPD. Culham St Gabriel's Trust run training courses for RE leaders and have funding currently to help RE teachers study a module from the Chartered Teaching College applying educational research. The deadline to sign up is the end of November 2023.

RE resources - the British Library has a lot of resources on different religions available to teachers, especially KS2 teachers. The London Museum has an extensive range of clips and resources to help teach Judaism.

NASACRE provides training and a wide range of courses are on offer in 2023-2024.

#### 18. Draft Annual Report

The advisor to the SACRE provided a short briefing on the annual report which provides a summary on RE and collective worship. An action plan is also provided for the following three years.

A survey on withdrawals was completed from RE and worship and it was noted in the annual report that the numbers were really low. This survey is completed every year.

Once agreed, the annual report is sent to the national body and the Department for Education.

It was noted that all training was up to date for SACRE members, due to the availability of training provided and the way it was provided.

The SACRE advisor informed that the SACRE looked at both RE and collective worship in schools. Collective worship can be provided by schools in many different ways to enable reflection. Collective worship was monitored in a variety of ways and it was noted that a survey was provided to schools. The RE Leaders were asked if they had seen the survey circulated, however a number had not seen it. It was suggested that the email for the next survey would be sent for the attention of the RE leader as well as the admin office.

The training on collective worship was really successful and it was expressed that the training needed to be offered again to offer the support to schools. A date for further training would be set and circulated round to schools and SACRE. Governor training has been set for March 2024.

One member of SACRE was mentioned nationally for his service to SACRE which would be included in the Chairmans introduction of the report.

A future item for the monitoring group was to discuss training and to report back to the SACRE on this.

It was noted that to enable a better transition for students between primary and secondary schools, a meeting with all RE Leaders from both settings would be beneficial, possibly in February 2024he SACRE advisor would arrange this.

RESOLVED:

#### 19. **Review of the Constitution**

Thanks, were give to Sarah Philipsborn and Justin Thorne for the work that had been undertaken to produce an updated version of the constitution.

There was some discussion regarding paragraph 6.4 which needed to be reworded.

More information around the youth voice was provided to look at a small conference. A date was being sought and would be circulated to SACRE members. Discussion took place regarding a survey for the update of RE in secondary schools and the uptake for GCSE levels.

# **Executive Summary**

- 1. **Purpose of report:** The purpose of this report is to inform SACRE of the findings and discussions that took place during the meeting of the SACRE monitoring subgroup on 4 March 2024. SACRE has a statutory responsibility to monitor the effectiveness of the agreed syllabus and this group meets before each full SACRE meeting in order to support SACRE in fulfilling this responsibility.
- 2. Those present at the meeting were: Justine Ball (Sacre Professional Adviser), Harry Kirby, Beth Feltham and Cllr Debbie Andre. The new Service Director for Education, Inclusion and Access, Naomi Carter, also attended the meeting and was introduced to everyone.
- 3. The group received updates on professional RE education, monitoring the effectiveness of RE and visits to schools. It also discussed the recent Youth Voice to SACRE event and governor training during the meeting.

### Recommendation

4. That SACRE notes the findings of the monitoring group meeting.

#### Inspector/Adviser Updates

5. HIAS RE Network meetings have taken place on the Island for primary and secondary teachers in the Spring terms. The secondary network that took place in the Autumn term focused on CPD on Pagan traditions, Living Difference IV and the work of Peacejam, who would be presenting a workshop at the Youth Voice Event. The primary meeting was face to face and focused on assessment and progression in RE and developing an action plan for RE in the summer term.

- 6. A repeat of the online training session for Island governors on RE and Collective Worship took place on 12 March 2024 and was organised by the monitoring group to raise the profile of RE in schools and to provide expertise to help with this.
- 7. It was noted that the Jerusalem Trust may provide up to £600 per school in a grant for resources to support the teaching of Christianity and the application form for this can be found here: <u>The Jerusalem Trust (regrants.org.uk)</u>

#### Other sources of evidence and effectiveness of RE

8. The Inspector/adviser reported that there had been no Ofsted reports for the Island specifically mentioned RE in both primary and secondary schools leading up to the date of this meeting

#### SACRE school visits

9. There had been no further primary or secondary visits undertaken for RE in this period, but a primary and a secondary visit to schools were agreed for the summer term. The report from these would be discussed at the next monitoring group meeting.

#### Information from other HIAS discussions including inspection/advisory visits

10. The monitoring group discussed a visit to a school with a focus on a general review of provision. A variety of lessons were observed, and meetings involved a discussion of the curriculum, data, and areas of focus for a follow up visit. Particular areas of focus included progression and outcomes, especially for higher prior attaining students and learning strategies for RE lessons.

#### GCSE Preliminary Results

- 11. The monitoring group talked through the GCSE results data for the Island. In summary, analysis of the data shows:
  - The Island continues to see a gap from the national average with results at 4+ being 15% below national. This is a slight widening of the gap from 2019 when it was 12%. It was noted that only a small number of pupils sat GCSE RS this year and this number had decreased over the last few years.
  - The Island saw a 6% drop in 7+ grades and 17% at 5+. This was reflected nationally too, but the Island has seen a sharper decrease than the national picture.
  - The Island has seen a closing of the gap with SEND students, which is a positive to note. At 4+ the gap with national is 15%, compared with 33% last year. The pattern is similar at 5+, but at 7+ the gap with national is only 2% compared with 7% in 2019, showing some progress with the top grades.
  - The Island has seen a widening of the Pupil Premium gap with national results from both last year and 2019 with 33% achieving 4+ compared to 57% nationally.
- 12. Case studies of excellent practice and learning journeys to raise standards will be discussed further at the full SACRE meeting, including work undertaken to raise standards by Beth Feltham, member of the SACRE and other schools. These will be shared with other teachers to promote best practice.

# **Executive Summary**

- This report seeks to update and inform SACRE of key national developments, for example the work of the Religious Education Council (REC), the National Association of SACREs (NASACRE), the Association of University Lecturers in Religious Education (AULRE) and initiatives being led by the Culham St Gabriel's Trust.
- 2. NASACRE is running its annual Westhill/NASACRE award and has invited SACREs to submit their applications for an Award. The £4000 (max) award is intended to fund a SACRE-led project that will enhance the quality of RE and or collective worship in local schools, with the potential to have wider, lasting impact. The theme for this year is *Education into Diversity*. The <u>Westhill website</u> and the NASACRE website has further information. **The closing date for applications is 31 March**.
- 3. The NASACRE annual conference is **Monday 20 May 20 24. It is in York, but also available online for SACRE members. The theme is:** *How can SACREs support high quality RE & Collective Worship?* SACRE members are invited to contact the SACRE clerk if they wish to attend and there is a maximum of 2 delegates per SACRE.
- 4. There is one further NASACRE webinar coming up this year:

- 5. Nationally, the Ofsted Annual Report from the Chief Inspector for the year 2022/23 refers to RE being of poor quality across England. The report can be referenced here: <u>The Annual Report of His Majesty's Chief Inspector of Education, Children's Services and Skills 2022/23 GOV.UK (www.gov.uk)</u>. SACRE members are encouraged to read the report and be aware of the national picture, although it is not reflected locally. The Ofsted subject report on RE is due out this year and will be circulated as soon as it is available.
- 6. RE Hubs continue to run FREE Places of Interest and School Speaker training (POI &SS). The next dates for training are, 26 March, 18 April 2024 and all are online. SACRE members are encouraged to register for training if they have not already and to pass the details onto other school speakers they might know. Further details are available here: <u>Register as a school speaker (re-hubs.uk)</u>
- 7. NATRE (National Association of Teachers of Religious Education) has produced a toolkit for schools on bullying and belief:

'This Bullying and Belief toolkit is a resource to support schools to deal with the topic of religious bullying. It contains five 60-minute lessons for Primary and Secondary schools, with resources and films on which to base your teaching within RE lessons. Alternatively, the five lessons have been planned so that they can run as a drop-down day or be used in tutor time or in PSHE sessions. The toolkit also contains resources for organising assemblies around this theme.'

- 8. The University of Nottingham is running a film making competition for GCSE and A-Level RE students. The theme this year is "Our Changing World: Census 2021 and Religion". There is a prize of £100 for the winning GCSE and A-Level entrant. More information can be found here: <u>David-Garlick-Prize-Competition-2024</u> (nottingham.ac.uk)
- 9. AREIAC (Association of RE Inspectors, Advisers and Consultants) and AULRE (Association for University Lecturers in Religion and Education) will be holding a joint conference on June 20th-21st at Newman University, Birmingham.
- 10. AREIAC will be running a webinar 'Handling Sensitive Issues around Religion in Schools' on Monday 29th April 2024 1600-1730.
- 11. A repeat of the Governor training session that was held in July 2023 took place on 12 March 2024 with governors representing 11 different schools on the Island. The theme of the training was understanding RE and Collective Worship in school and the role of SACRE and governors in supporting high quality RE and Collective Worship.
- 12. A secondary Youth Voice event for RE took place on Friday 1 March at The Bay Church of England Secondary school, with young people from The Bay, Carisbrooke, Medina and Christ the King schools. Members from our SACRE were able to visit the event and to support it and will report back to SACRE during the meeting. The focus for the day was the question

13. The purpose of SACRE Youth Voice event was to allow students the opportunity to express what matters to them, which will help inform SACRE in identifying priorities for RE provision on the Island and exploring what resources and opportunities SACRE can provide and support with. Feedback from schools has been that a current concern for young people on the Island is the challenge of human caused climate change. This event aimed to allow year 9 students to explore in more detail issues surrounding this cause. Students took part in a series of workshops, had the opportunity to work together in discussing the issues raised and shared their perspectives and vision for the future.

The event was very successful with positive comments received from the young people who attended. Ideas for further Youth Voice events are welcomed.
