The all-through Church of England school will cater for boys and girls irrespective of ability, aged 4 – 16, with effect from 1 September 2018.

# Alteration description

**3.** A description of the proposed alteration and in the case of special school proposals, a description of the current special needs provision.

The proposal is to change the upper age range of The Bay CE Primary School so as from the 1 September 2018 the school is a 4 - 16 and not a 4 - 11 school. This will be achieved through the utilisation of Sandown Bay Academy site and buildings.

## **School capacity**

- **4.**—(1) Where the alteration is an alteration falling within any of paragraphs 1 to 4, 8, 9 and 12-14 of Schedule 2 (GB proposals)/paragraphs 1-4, 7, 8, 18, 19 and 21 of Schedule 4 (LA proposals) to The School Organisation (Prescribed Alterations to Maintained Schools) (England) Regulations 2007 (as amended), the proposals must also include
  - (a) details of the current capacity of the school and, where the proposals will alter the capacity of the school, the proposed capacity of the school after the alteration;

The all-through CE school will cater for pupils between the ages of 4 and 16 and have a total capacity for 1620 pupils. The existing primary school has a capacity of 420 pupils.

(b) details of the current number of pupils admitted to the school in each relevant age group, and where this number is to change, the proposed number of pupils to be not admitted in each relevant age group in the first school year in which the proposals will have been implemented;

For the 2018/19 academic year, the school will admit up to 60 pupils at Year R and 180 pupils at Year 7. All Year 6 pupils at the all-through school will be able to transfer automatically to Year 7 if they wish, however, additional Year 7 places will be offered if fewer than 60 children transfer to Year 7, so that the total number of children starting Year 7 is 240. Pupils will be admitted to the school in accordance with published admissions policies. It is intended that there will be no change to the oversubscription criteria used in the primary school's policy.

(c) where it is intended that proposals should be implemented in stages, the number of pupils to be admitted to the school in the first school year in which each stage will have been implemented;

The number of pupils registered at The Bay CE Primary School in the October 2017 is 421.

## **Implementation**

**5.** Where the proposals relate to a foundation or voluntary controlled school a statement as to whether the proposals are to be implemented by the local education authority or by the governing body, and, if the proposals are to be implemented by both, a statement as to the extent to which they are to be implemented by each body.

The proposals will be jointly implemented by the Cornerstone Federation Governing Body and the Local Education Authority. An Implementation Group will be formed which will include School, Diocese and Local Authority representatives. They will collectively oversee the transition of the school from a 4 – 11 provision to 4 – 16 provision across the exiting site and Sandown Bay Academy site once available.

#### **Additional Site**

**6.**—(1) A statement as to whether any new or additional site will be required if proposals are implemented and if so the location of the site if the school is to occupy a split site.

As part of the proposal, the Bay CE Primary School will take over the existing Sandown Bay Academy side once the Academies Enterprise Trust (AET) closes the existing provision in August 2018. The site is currently leased by the Isle of Wight Council to AET but, at point of closure will revert back to the control of the IW Council who will put in place suitable arrangements to allow it to form part of the proposed 4 – 16 offer. The sites are 0.5 miles apart with safe walking routes.

The Isle of Wight Council will provide the additional site required. The detail of the tenure at this point has yet to be fully discussed and will form part of the on-going work of the Implementation Group.

# **Objectives**

**7.** The objectives of the proposals.

To ensure the continuation of high quality secondary education is provided in the Sandown Bay area once the existing AET academy is closed. Failure to achieve this would mean secondary age pupils having to travel unacceptable distances to access education and a significant financial burden being placed on the local authority Home to School Transport budget.

As this is an expansion of age range of Church of England school the newly formed 4 – 16 school will also be of the same religious character.
