This statement sets out the Isle of Wight Council's flexible eligibility criteria for the Energy Company Obligation (ECO4) scheme from April 2022 – March 2026.

The ECO4 scheme will focus on supporting low income and vulnerable households. The scheme will improve the least energy efficient homes helping to meet the Government's fuel poverty and net zero commitments.

The flexible approach for Local Authorities (LAs) to identifying fuel poor and vulnerable households who may benefit from heating and energy saving measures is referred to as "ECO4 Flex". It is only available to private sector housing, that is, households in owner occupied or private rented accommodation.

The Council welcomes the introduction of the ECO4 Flex eligibility routes as it helps the Council achieve its plans to improve the homes of those in fuel poverty or vulnerable to the cold.

The Council is publishing this Statement of Intent (SoI), on the **XX/XX/2022** to confirm that each of the households declared will adhere to at least one of the three available routes outlined below:

Route 1: SAP bands D-G households with an income less than £31,000. This cap applies irrespective of the property size, composition, or region.

Route 2: SAP bands E-G households that meet a combination of two of the following proxies:

Proxy 1) Homes in England in Lower-layer Super Output Area 1-3 (LSOA) ¹
Proxy 2) Householders receiving a Council Tax rebate (rebates based on low income only, excludes single person rebates).
Proxy 3) Householders vulnerable to living in a cold home as identified in the National Institute for Health and Care Excellence (NICE) Guidance. Only one from the list can be used, excludes the proxy 'low income'.
Proxy 4) A householder receiving free school meals due to low-income.
Proxy 5) A householder in receipt of, or having received in the 24 months prior to the publication of this SOI, a Disabled Facilities Grant.
Proxy 6) A household referred to the council for support by their energy supplier or Citizen's Advice, because they have been identified as struggling to pay their electricity and gas bills.

* Note proxies 1 and 5 cannot be used together.

Route 3: SAP bands D-G households that have been identified by their doctor or GP (or the NHS Trust) as having an occupant whose health conditions may be impacted further by living in a cold home. These health conditions may be cardiovascular, respiratory, immunosuppressed, or limited mobility related.

This is because the council has identified a positive correlation between households who suffer from long-term health conditions and living off a low-income, with living in poorly insulated homes.

Declaration and evidence check confirmation

All potentially eligible households should apply through one of the council's approved ECO installers or an installer approved by their energy supplier for ECO delivery, to ensure that they can either benefit from the scheme or be assessed for eligibility under any other relevant programme. It should be emphasised that the inclusion of a household in an Eco Flex declaration does not guarantee that a measure will be installed in their home by an energy supplier. Decisions by energy suppliers on whether to install a measure may depend on:

- The survey carried out by suppliers, or their agents / contractors, and costs calculated;
- The energy savings that can be achieved for a property;
- Whether suppliers have achieved, or are close to achieving, their targets; and
- Other commercial considerations

Suppliers, or their agents / contractors, will carry out an assessment to decide which measures the property should receive.
