Arreton PC	<p>Are pleased that the Planning Department is looking to implement a new strategy regarding enforcement. However, the members do have some concerns regarding the proposed new strategy. These can be summarised as the need for actions to back the new strategy up, and the suggestion that smaller councils such as Arreton could purchase an agreed number of hours a year (based on an hourly rate) would be on the basis of an insurance policy in that if any of the hours are needed, they are there and if they are not required, then so be it. It would be useful if there was a mechanism by which extra hours could be purchased on the, hopefully, very rare occasions when more than the allotted time may be needed.</p>	<p>The need for action to back the strategy up is very much agreed with, and it is proposed that there will be greater visibility of the planning enforcement work undertaken to both celebrate success and act as a deterrent to others.</p> <p>This is agreed with, and reflects a number of conversations with other (often more rural and/or smaller) local councils.</p> <p>Officers will be exploring how this can be achieved, and it is considered that this could be achieved outside of the Strategy.</p> <p>Thank you for taking the time to review the draft strategy and respond.</p>
