Thank you for your response below.

From a Licensing perspective and looking at the companies website which is <u>Locations | Eat Street IOW</u> the locations to where they will temporarily inhabit are primarily non-residential, with the exception of Mill Hill Road in Cowes.

The business is also operating as a food led operation therefore any alcohol that is being collected will in the vast majority be complimented by a food order. Customers will also not be able to just turn up to place an order as this has to be made online prior to the collection.

With the above points in mind and from a licensing perspective I would state that there would be no significant impact on the licensing objectives.

Should any instances of nuisance be reported due to the direct activity or authorisation contained within the licence (if granted) then we and potentially Environment Health would look to address such issues through our respective enforcement powers.

During the consultation period the Police (from a crime and disorder perspective) and Environmental Health (from a nuisance perspective) have not submitted any concerns in relation to the proposed activity, therefore could I ask that CTC review the above and inform us as to whether you still wish your representation to stand.

If this is the case then Licensing will look to progress to arranging for a hearing to take place where CTC can attend to explain and discuss there concerns in order for the Licensing Sub Committee to come to a determination in relation to the application,
